





Gentlemen,

This letter is to confirm my willingness to accept Dr. Salvatore Reina for a post-doctoral training program in my laboratory.

Dr. Reina is interested in learning diagnostic techniques for the detection of human T-cell leukemia virus (HTLV-I and II infections in humans. Although these viruses are not prevalent in Italy, patients with Human Immunodeficiency Virus (HIV) have been shown to be infected with both HTLV-I and HTLV-II. Furthermore, since HIV-associated neoplasia are common among patients with AIDS, it will be extremely useful to learn diagnostic procedures for the isolation of retroviruses from the blood and neoplastic tumors of patients with dual infections.

Since my laboratory is one of the major AIDS research and reference centers in this country, all virus isolations and confirmatory tests for the Los Angeles County area are performed in my laboratory. After discussing with Dr. Oliviero Varnier of Instituto di Microbiologia, Genova, Italy, I am convinced that it will be important for Italian scientists to acquire modern technologies and expertise in diagnostic procedures for identification of retrovirus-induced diseases in humans. This is pertinent and timely because the intravenous drug abusers in Italy may be at risk for retroviral infections of both HIV, HTLV-I or HTLV-II. I therefore strongly recommend that Dr. Reina be encouraged to join a training program and learn diagnostic and other research techniques in human retrovirology.



Dr. Salvatore Reina is a guest worker in the Laboratory of Tumor Cell Biology since August of 1988. Dr. Reina came from the Istitute of Microbiology of Genova, Italy.

Our laboratory has continued interest in a project being jointly done between LTCB and the Institute of Microbiology viz., the development of a rabbit model for vaccine purposes. They have had success in accomplishing this to a degree, although it needs more work. I hope that Dr. Reina will continue to be associated with this project because the successes obtained in this area directly reflect his contribution.

In addition, Dr. Reina has also been following a number of persons with HTLV-I like infection. It would be exciting to follow them to isolate the virus infecting these people to establish this pocket of endemicity in the southern part of Italy. 


